This Memorandum of Understanding (MOU) is hereby signed by both Parties on this 24<sup>th</sup> Day of May, 2023.

#### Purposes of the MOU:

- 1. To introduce training sessions for govt. job preparation.
- 2. To introduce skill development programme / Vocational Courses.
- 3. To conduct interest assessment and aptitude test.
- 4. To introduce and conduct any other program / course / training which is mutually agreeable and beneficial to both parties.

#### Specific Reads from NEP-2020 that this MOU intends to implement:

A) "By 2025, at least 50% of learners through school and higher education (college) system shall have exposure to vocational education ..."

B) "Higher education institution will offer vocational education either on their own or in partnership with industry and other institution."

C) "Developing and implementing a holistic assessment and evaluation system ... to conduct interest assessment and aptitude test ... for learning in various vocational areas."

#### Specific Reads from NEP-2020 that this MOU intends to implement:

To achieve this objective, secondary schools will have to collaborate with Industrial Training Institutes (ITIs), Polytechnics, Local Industry, etc. Skill labs will also be set up and created in the schools in a Hub and Spoke model, which will allow other schools to use the facility. Higher education institutions will offer vocational education either on their own or in partnership with industry and other institutions.

A) "By 2025, at least 50% of learners through school and higher education (college) system shallhave exposure to vocational education ..."

B) "Higher education institution will offer vocational education either on their own or inpartnership with industry and other institution."

C) "Developing and implementing a holistic assessment and evaluation system

... to conductinterest assessment and aptitude test ... for learning in various

ocational areas."

#### Terms and conditions:-

- 1) This agreement is made between the two parties to work together in such a manner that will promote mutual, agreeable and beneficial collaboration.
- 2) The Second Party agrees to provide skill development program and aptitude test programme free of cost for the holistic development of the students.
- 3) This agreement promises to safeguard and sustain sound managerial and administrative commitment with regards to all matters related to the project.
- 4) The Second Party agrees to organize training session for willing students to prepare for competitive examinations for Govt. job 2 hours per week and they shall not charge any course fee from students. However, the students will have to pay Rs.100/- (Rupees one hundred only) toward maintenance, per month.
- 5) The First Party shall allow the Second Party to use a single room for setting up a computer laboratory once a week for 2 hours to conduct training session for students aspiring for Govt. service.

## Termination and / or Expiration of the Agreement:

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of **five year**. Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives. ### Non-Exclusivity:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

#### **Special Provisions:**

- 1. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
- 2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- 3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MOU or any subsequent associated agreement informally.
- 4. Neither party can misuse this MOU by involving the name of the other without the written consent from the other party.

#### **Dispute Resolution:**


If any dispute arises in respect of the MOU, in that case both the Organizations will discuss and settle the matter amicably.
