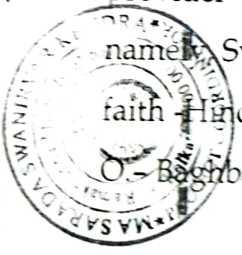
AND

NOW THROUGH THIS AGREEMENT BOTH THE PARTIES WITNESSETH as follows and accept:

1. Cooperation program shall be encompassing the following domain,
 - a. Skill based training & certification/add on certification courses.
 - b. Organizing Webinar/Conference for Skill India events.
 - c. Placement/Recruitment Drive.
 - d. Awareness campaign for aspiring candidates.
 - e. Up skilling, RPL(Recognition of Prior Learning) and any other courses that require Skill India platform.
2. This agreement is valid for a period of Three (3) Years from the date of signing. After a period of 1 year , this would be further reviewed and extended by both parties as per mutual convenience.
3. Both the parties have mutually agreed that there is no financial dealing between the parties relating to this agreement. However, grants received from Public resources like UGC for specific training program may be utilised following workable methodology.
4. Any litigation arising out of the program shall be amicably settled by discussion between both the parties.
5. This MOU will be deemed to be in force from the date of signing by both the parties.
6. Either party can terminate the MOU by clear and official letter/mail by giving one month's notice to other party. However, all the on-going programs shall continue till conclusion irrespective of the termination.
7. Both the parties agrees to conduct the program in offline mode. However, some classes examination/assessment can be performed online only for which FIRST PARTY shall allow utilisation of in-house Computer Labs for such service on chargeable basis based on mutual discussion time to time.
8. SECOND PARTY shall indemnify the FIRST PARTY against damages caused by litigation from third party, students, parents and college authority and any stake holder of the training program.
9. FIRST PARTY undertakes Training courses under Skill India programs both on paid and non-paid mode. Paid courses are charged minimally and FIRST PARTY being a Internationally renowned Charitable Organisation is offering these paid courses lowest in the Industry without any prejudice.
