THIS AGREEMENT is made on 07TH DAY OF JUNE, 2023

BETWEEN

Women's College, Calcutta established in 1937, is a government-aided general degree college in Kolkata, India. The college offers undergraduate degree courses in arts and science. The College is affiliated with the University of Calcutta and is also recognized by The University Grants Commission (UGC).

AND

Fragrant Creation

Fragrant Creation is a proprietorship, and micro enterprise (Udyam Reg. No. UDYAM-WB-10-0027858), represented by acclaimed filmmaker and director Sourav Sarkar, conducting film – production (making), film – exhibition, film – analysis and academic sensitization on films, serving interdisciplinary connection between film medium and various fields of study and research in social sciences.

1. Purpose of the Agreement

The Women College, Calcutta and the Fragrant Creation intend to develop cooperation and collaboration in research for development, training, joint diploma/certificate programs/courses, and other agreed activities that further the aims and objectives of the Institutions as follows:

- a) To organize and conduct certificate courses, value added courses, add – on courses, seminars, conferences, workshops pertaining to film – medium / film making (analysis and development of technical skill) centrally with participation from all / any of the academic departments, subject to the availability of funds.

b) To organize and conduct seminars, conferences, observance of national days, workshops pertaining to film – medium / film analysis (analysis and development of technical skill) individually in collaboration with PG Departments of Arts / Social Sciences and/or UG Departments of Arts / Social Sciences, subject to the availability of funds.

2. Major Objectives/ Scope of the Agreement

a) Fragrant Creation, in collaboration with Women's College, Calcutta may arrange for joint workshops/training/seminars/conferences/certificate courses/ value added courses/ add – on courses etc. The location for the said programmes and the participating charges may be defined upon mutual consent. However, the number of committed students for each workshop or certificate course or value-added course, should be decided mutually on a prior basis.

b) WOMEN'S COLLEGE, CALCUTTA and Fragrant Creation will jointly promote the activity that would be conducted. The participants should be the students and academic members under the aegis of Women's College, Calcutta.

3. Current and Future Objectives/Prospect of the Agreement

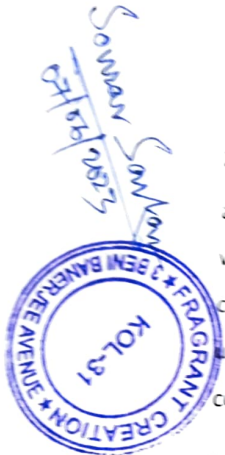
1. Research collaboration on film medium/ Value Added Course/ Certificate Course/ Grant Writing Support on film medium/Publication & short film production/ Book Chapter Writing in relation to film medium /Faculty Development Programs. These can be an obvious consequence of long-term association between both parties.

4. Understanding between the two Parties

a) Both parties acknowledge the need to create an ecosystem for promoting innovation and entrepreneurship and are interested in partnering to further this cause.

b) There is a need to inculcate an entrepreneurial & problem-solving mind-set among the students and youth.

c) Both parties will work on applying and conducting various government skill Development projects for the benefit of a wide spectrum of students.

5. Non-exclusivity

The relationship of the parties under this Agreement shall be non-exclusive and both the parties, including their affiliates, subsidiaries, and divisions, are free to pursue other agreements or collaborations of any kind.

6. Termination of Agreement

This Agreement commences from the date of the last signing and shall be in force for 3 years. The Agreement may be terminated at any time by mutual consent or by 6 months' notice by either party. It may be amended, modified, extended, or renewed only by the written consent of both Parties. The Institutions agree to review this Agreement six months prior to the end of the 3-year term.

7. Confidentiality

- a) The parties to this Agreement undertake to treat as CONFIDENTIAL AND PRIVILEGED information of either party. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- b) Except as reasonably required, both the parties covenant that neither the party shall at any time during this Agreement or at any time after it is terminated disclose or reveal to any person/organization or otherwise make use of confidential information including any of the trade secrets, confidential operations, processes or dealings or any information concerning the parties and their subsidiaries, business, finances, transactions or affairs of the affiliates/agencies or any of their ventures which may come to the knowledge of either the party during the period.
- c) During the period of the Agreement, each party agrees to respect each other's freedom of operation. Neither the parties shall interfere in the affairs/functioning of the other.
